The 1,500 pages is an attack on our women/girls, making the administrative rules unlawful. Supreme court overturning the 'chevron doctrine' strengthens the argument (ruling occurred a few weeks ago). On top of that, this rule making was done by executive order and that makes this change temporary in nature. Also unlawful was the use of executive order to change the definition of "sex", the whole basis of Title IX is based of "sex" = male or female.

Schools and colleges largely could not ban nonbinary and transgender students from sports teams, the Biden administration said Thursday in a [long-promised](#) proposed rule to protect these students from discrimination.

"Every student should be able to have the full experience of attending school in America, including participating in athletics, free from discrimination," [U.S. Secretary of Education Miguel Cardona](#) said in a statement that included details of the rule.

The proposal comes at a time [when a number of states are banning transgender students](#) from participating on sports teams that align with their gender identity.

"Under the proposed regulation, schools would not be permitted to adopt or apply a one-size-fits-all policy that categorically bans transgender students from participating on teams consistent with their gender identity," the Education Department said.
